## CHARLESTON BOARD OF EDUCATION REGULAR MEETING February 17, 2014

The Charleston Board of Education met in regular session on Monday, February 17, 2014 at 6:00 p.m. in the Fine Arts Building. Members present were: Mr. Trey Gage, Mr. Jeff Hayes, Mr. Joel McDonald, Mrs. Michele Schmitz, and Mr. Brian Verkamp. Also present were Mr. Jeff Stubblefield, Superintendent; Mr. Shane Storey, High School Principal; Mrs. Melissa Moore, Middle School Principal; Mrs. Carl Underwood, Elementary School Principal; Mrs. Susan Brown, Federal Coordinator and Curriculum Specialist, and Mrs. Rita Gramlich, District Treasurer.

Mr. Trey Gage called the meeting to order at 6:01 p.m..

A motion was made by Mr. Jeff Hayes and seconded by Mrs. Michele Schmitz to approve the consent agenda as listed. Motion carried 5-0.

Mr. Stubblefield reported the district has missed 5 days due to inclement weather. Two days were made up on January 20 and February 17. April 18, May 27 and May 28 will also be used as make-up days.

Mr. Stubblefield reported the administration is currently awaiting guidance regarding School of Innovation which would permit the district to possibly begin the 2014-15 school year one week earlier.

Mrs. Susan Brown presented this year's Benchmark and End-of-Course testing schedule.

A new maintenance job description was discussed regarding the employment selection of the next maintenance employee.

The board was presented a brief demonstration of new LED light fixtures that last 5 times longer and use 30% less electricity.

Mr. Stubblefield reported information regarding the 3-A State Basketball Tournament, softball, baseball, and spring break (March 24-28). He also said that the high school has received a new basketball scoreboard with the expense to be reimbursed by the Steve Cox family.
