

**CHARLESTON BOARD OF EDUCATION
SPECIAL MEETING
APRIL 6, 2026**

The Charleston Board of Education met in special session on Monday, April 6, 2026 at 5:30 p.m. Members present were: Mr. Jeff Hayes, Mr. Chad Keener, Mrs. Lauren Robinson, and Mr. Jarrad Ward. Also present were Mrs. Melissa Moore, Superintendent; Mrs. Rachel Fisher, High School Principal, Mr. Josh Underwood, Middle School Principal; Mrs. Kelsey Noble, Elementary School Principal; Mrs. Angie Haney, Federal Coordinator, and Mrs. Pam Rankin, Business Manager. There were also several qualified electors and visitors present.

Mrs. Lauren Robinson established a quorum and called the meeting to order at 5:30 p.m..

There were no public comments from visitors.

Mrs. Melissa Moore welcomed those in attendance.

The following qualified electors in attendance who submitted valid petitions were given the opportunity to speak for 5 minutes: Melanie Keith, Jason Little, Kevin Lynch, Jeremy May.

Mrs. Lauren Robinson announced that, if there was no objection, and following Robert's Rules of Order, the "nomination" for Position (2) Two would be conducted by written ballot.

After members had selected their nomination, Mrs. Lauren Robinson directed the principals to collect the ballots and announce who received the most nominations.

Three principals collected and counted the nominations. Mrs. Rachel Fisher announced that Kevin Lynch had received the most nominations.

A motion was made by Mr. Jarrad Ward and seconded by Mr. Chad Keener to accept the resignation of Ryan Rachuy, Bus Driver, effective at the end of the 2025-26 school year. Motion carried 4-0

A motion was made by Mr. Chad Keener and seconded by Mr. Jeff Hayes to employ Ryan Rachuy, Coach, for the 2026-27 school year, with a .3212 stipend. Motion carried 4-0.

A motion was made by Mr. Jeff Hayes and seconded by Mr. Chad Keener to employ Joshua Corter, Bus Driver, for the 2026-27 school year. Motion carried 4-0.

A motion was made by Mr. Jarrad Ward and seconded by Mr. Jeff Hayes to employ Jordan Shelby, Certified Teacher, Golf, Bus Driver, for the 2026-27 school year. Motion carried 4-0.

A motion was made by Mr. Chad Keener and seconded by Mr. Jeff Hayes to employ Rachael May, High School Librarian, for the 2026-27 school year. Motion carried 4-0.

A motion was made by Mr. Chad Keener and seconded by Mr. Jeff Hayes to adjourn at 6:01 p.m. Motion carried 4-0.
